

**President's Response**

**Issue/Concern:** Wheelchair Accessibility

**Summary of Issue:**

Currently, there are accessibility issues for wheelchair dependent persons to restrooms and classrooms in Mohr Hall. The recommendation is that automatic openers for doors into restrooms and classrooms be installed.

**Action Taken:**

- 10/07/2021: Executive Council heard Campus Issue CI 20-21-05 and recommended that the issue be referred to President's Cabinet to determine next steps.
- 12/02/2021: Executive Council discussed CI 20-21-05. After discussion, Council recommended that the issue be referred to Interim VPA Stephanie Smith for investigation and response.
- 12/14/2021: M. Kekahu forwarded CI 20-21-05 to Interim VPA Smith via email, and requested that next steps be determined.
- 02/03/2022: Executive Council asked that a follow-up email be sent and requested an update on the progress of this Campus Issue at the March 2022 meeting.
- 02/08/2022: M. Kekahu sent a follow-up email to Interim VPA Smith requesting an update and/or progress of work.
- 02/11/2022: Interim VPA Smith notified M. Kekahu via email that work orders had been submitted to Facilities Maintenance (FM). The work orders requested that push buttons be installed in the gender neutral bathrooms in Mohr Hall. Interim VPA Smith and Director Margaret Lednicky reviewed the request with FM at their monthly meeting to confirm that they had received the requests and when they will schedule the work. In addition, Interim VPA Smith and Director Lednicky have asked that push buttons also be installed in the Student Services building.
- 04/07/2022: Executive Council was updated on the progress of CI 20-21-05. VPA Smith attended Executive Council and provided the following update: Work orders have been submitted for installation of push buttons in gender neutral restrooms in Mohr Hall and Student Services Building. VPA Smith will follow up on identifying what issues are present in classrooms in Mohr Hall, and will make modifications if needed.


Executive council voted to close the Campus Issue with the following recommendation: Interim VPA Smith will evaluate Mohr Hall classrooms for potential accessibility issues.

**President's Response to Executive Council:**
